## Expert Witness Courtroom Testimony Course

The Expert Witness Courtroom Testimony Course (EWCTC) is a very comprehensive training module. **Date – August 15-17, 2008 in Tucson,**

### **Goal-**

The overall goal of the Expert Witness Courtroom Testimony Course is to enable the applicants for the Certified Fire Investigator program to fulfill the court testimony requirements under “Experience Other (page3)” of the CFI application process.

### **Activity-**

The course is two and one-half days of work with instructors and attorneys. There is a considerable amount of out of class work, both before the course begins and at night during the course. The student expert will work with an instructor or attorney, one-on-one, and at times two (instructor / attorney)-on-one (student expert) setting during the length of the course.

### **Instructors-**

There are instructors in the State of Arizona who are Certified through the I.A.A.I. to teach the course. Each instructor has years of experience in the field of fire investigation, testimony at both depositions and trials and has successfully completed the EWCTC and the EWCTC Instructor's course.

### **Attorneys-**

Practicing attorneys are experienced.

### **Facility-**

As required by the I.A.A.I., the testimony part of the course is in a courtroom and all efforts are to evoke a realistic courtroom experience.

The course requires completion of pre-class assignments with papers due the first day.

The EWCTC requires a lot of preparation and work on the part of the instructors and the students and seating is very limited.

The cost for in-state members is \$325.00 and non-members or out of state is \$425.00. Must be paid in full to receive course material and guaranteed a slot.
